WHAT WE’RE ASKING OF YOU DURING THE CAMPAIGN!

- 1** **Conduct mobile plant assurance activities every week** such as LLCs, CCCs and CRP Audits.
- 2** **Prepare and run** toolbox talks using a campaign supplied template or one of your own that is relevant for your team.
- 3** **Coordinate your team** as relevant to attend a planned masterclass and/or mock trial session.
- 4** **Organise Heavy Metal Insights with workers** that share an operators’ view of the world and examples of mobile plant safety controls.
- 5** **Complete Heavy Metal Monday Challenges** that will be communicated each week of the campaign.
- 6** **Make an impact** by identifying mobile plant on your site and checking a plant risk assessment has been recorded.

EVERY WEEK

Elevate safety assurance activity!

Conduct mobile plant assurance activities (LLCs, CCCs, or CRP Audits).

WEEK 1

Mon 2 Oct 2023 – Fri 6 Oct 2023

Run the Heavy Metal Rules Toolbox Talk with all workers at your site. Share why we are focusing on mobile plant safety.

Promote the Heavy Metal campaign

Print and display Heavy Metal posters at your worksite. Share Heavy Metal case studies with the team. Update teams background with campaign template.

Complete blind spot training. Encourage others to do the interactive 5-minute Heavy Metal 360° training, too.

Check your leaders are attending an allocated mock trial session.

WEEKS 2, 3 & 4

Mon 9 Oct 2023 – Fri 27 Oct 2023

Prepare and run a weekly toolbox talk

Mix it up by sharing plant event and personal stories, or delivering one of the toolboxes on segregation, blind spots or pre-start checks. Encourage discussion!

Attend Heavy Metal on Trial Masterclass

(Wed 11 Oct, 11am-12pm AEST). A former SafeWork prosecutor will share insights from their mobile plant prosecution stories and answer your questions. This session cannot be recorded so not to be missed!

Encourage teams to share plant safety activities and examples on Yammer.

Elevate pre-start checks! Verify the conduct of in field pre-start checks. Share the Heavy Metal pre-start presentations.

WEEKS 5, 6 & 7

Mon 30 Oct 2023 – Fri 17 Nov 2023

Prepare and run toolbox talks. Deliver mobile plant toolbox talks on the campaign site e.g. slips, trips accessing plant, training and competency, and positive communications.

Plant Assessor Masterclasses x 2

(TBC Nov, 1-2pm AEST) Encourage SHEQ professionals and leaders to learn about Plant Assessor functionality, Plant Risk Assessments & Plant Pre-start Inspections.

Don't be deaf to Heavy Metal risks

Discuss the importance of mobile plant safety and tackling at risk behaviours with your team e.g., fit for work, seat belts, blind spot monitoring, and plant/people segregation.

WEEKS 8 & 9

Mon 20 Nov 2023 – Thu 30 Nov 2023

Prepare and run a toolbox talk Use this opportunity to focus this final week's toolbox talk on reviewing what your teams have learned and behaviours they have changed.
